

**Ansell Watch Your Back Twitter Sweepstakes
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Promotion Description: The Ansell Watch Your Back Twitter Sweepstakes (“Sweepstakes”) is a trade promotion that begins on August 18, 2014 at 12:00 A.M. (Midnight) Eastern Time (“ET”) and ends on December 31, 2014 at 11:59 P.M. ET (“Promotion Period”). Sweepstakes sponsored by Ansell, 19736 Dearborn Street, Chatsworth, CA, 91311 (“Sponsor”).

By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of entries and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes.

Eligibility: Open to legal residents of the fifty (50) United States and the District of Columbia who are 18 years or older, and who have internet access, and are healthcare professionals. Void where prohibited by law. Registration is a one-time requirement. If you are a returning visitor to Twitter, you will be prompted to log-in using your e-mail address. Limit of one (1) entry per person or per Twitter account per day during the Promotion Period. Anyone found using multiple Twitter accounts to enter the Sweepstakes may be disqualified. All entries must be made by the end of the Promotion Period in order to participate. Sponsor’s database clock will be the official time keeper for this Sweepstakes.

Automated or robotic entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the entrant and only as set forth above. You may not utilize the Message for any purpose except to enter the Sweepstakes.

Winner Selection: The potential winners of the Sweepstakes will be selected in a series of random drawings from among all eligible entries received throughout the respective Promotion Period. The random drawings for the Sweepstakes will be conducted on or about September 1, 2014, October 1, 2014, November 1, 2014, December 1, 2014 and January 1, 2015, by Sponsor or its designated representatives, whose decisions are final. Odds of winning will vary depending on the number of eligible entries received. Winners will be notified by a Twitter direct message immediately after the random drawing. Potential winners must accept a prize by replying to the Twitter direct message or other Sponsor-designated method within forty-eight (48) hours of notification, and must provide his/her full name, age and address when requested by Sponsor, for the purpose of establishing eligibility and administering the Sweepstakes. Sponsor is not responsible, and may disqualify an entrant, if the entrant's email or Twitter interface does not work or is changed. Any winner notification not responded to or returned as undeliverable may result in prize forfeiture and an alternate winner shall be selected.
